

COMMERCIAL LICENSE AGREEMENT

The Healthcare Data Trust & Closed-Loop RCM Intelligence System

LICENSE AT A GLANCE

- Your purchase grants a limited license to use the materials; ownership is not transferred.
- Editable Excel files, frameworks, diagrams, templates, and source materials may not be resold, redistributed, sublicensed, white-labeled, or posted for others to download.
- The number of people who may use or edit the materials depends on the license tier purchased.
- Professional users may provide clients with finished/static outputs, but may not give clients the editable toolkit or source templates.

This Commercial License Agreement ("Agreement") applies to the digital products, files, templates, workbooks, diagrams, frameworks, written materials, and related assets comprising The Healthcare Data Trust & Closed-Loop RCM Intelligence System (collectively, the "Materials"). By purchasing, downloading, opening, accessing, copying, or using any Materials, the purchaser or licensed organization ("Licensee") agrees to this Agreement.

1. License Grant

Subject to payment of the applicable purchase price and continued compliance with this Agreement, Licensors grants Licensee a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to use the Materials only within the scope of the license tier purchased. All rights not expressly granted are reserved by Licensors.

2. License Tiers and Authorized Use

License Tier	Authorized Users	Permitted Scope
Personal / Professional	One named individual purchaser	Use for the purchaser's own professional, business, analytical, educational, or consulting work. The purchaser may customize working copies and may create finished outputs for internal use or client service, subject to Section 3.
Team	Up to 10 Authorized Users within one licensed legal entity, unless the order page expressly states a different user count	Shared internal use by the licensed team or department. Authorized Users may access and edit shared working copies for the organization's internal operations. Source Materials may not be shared outside the licensed entity.
Enterprise	Employees and approved contractors of one licensed legal entity, subject to the Enterprise terms stated at purchase	Organization-wide internal use by the licensed legal entity. Controlled affiliates are included only if expressly identified in the purchase terms. Enterprise rights do not include resale, external redistribution, or white-label rights.

For purposes of this Agreement, an "Authorized User" is an individual permitted to access or use the Materials under the purchased tier. Access by any person beyond the licensed user count requires an upgraded or additional license.

3. Professional and Client-Service Use

- A Personal / Professional License may be used by the named purchaser to perform consulting, analytics, advisory, implementation, or professional services for clients.
- The purchaser may provide a client with finished deliverables created through use of the Materials, including reports, analyses, screenshots, static PDF exports, recommendations, populated charts, and other non-editable outputs.
- The purchaser may not provide a client with the original or modified editable Excel workbooks, blank templates, source diagrams, template libraries, editable frameworks, or other source Materials unless that client separately holds an applicable license.
- Where a proprietary diagram or framework is shown in a client-facing deliverable, the original title, copyright notice, and attribution to Chris Benefield must remain reasonably visible.
- If multiple practitioners at a consulting or professional-services firm will use the Materials, a Team or Enterprise License is required, as applicable.

4. Permitted Customization

Licensee may enter its own data, formulas, notes, assumptions, organizational identifiers, owners, dates, thresholds, statuses, and other business-specific content into working copies. Licensee may adapt calculations or layouts for its permitted internal use. Such customization does not transfer ownership of the underlying Materials or create a right to redistribute the adapted file.

- Internal organization names, project names, department names, and purchaser branding may be added in designated working areas.
- Licensors branding, copyright notices, proprietary framework names, license notices, and attribution may not be removed, obscured, or replaced in a manner that represents the Materials or underlying methodology as created by another party.

5. Prohibited Uses

Regardless of license tier, Licensee may not, directly or indirectly:

- Sell, resell, rent, lease, license, sublicense, assign, transfer, gift, or otherwise provide the Materials to another person or organization except as expressly permitted by this Agreement.
- Redistribute, upload, post, publish, email, transmit, place on a public or broadly accessible shared drive, or make the Materials available for download by unauthorized users.
- White-label, rebrand, relabel, or present the Materials, templates, frameworks, architecture, or methodology as Licensee's own product, intellectual property, course, certification, toolkit, methodology, or commercial offering.
- Remove or obscure copyright notices, license statements, attribution, proprietary names, trademarks, or embedded ownership notices.
- Extract, copy, or repurpose the templates, formulas, frameworks, worksheets, question sets, KPI libraries, architecture, or other substantive components to create a competing or substantially similar commercial product.
- Use the Materials as source content to train, fine-tune, seed, or populate a commercial AI model, template generator, knowledge product, course generator, or competing content library without separate written permission.
- Distribute modified or derivative editable versions of the Materials outside the scope of the purchased license, even if Licensee has substantially changed formatting, formulas, wording, or branding.
- Share login credentials, download links, purchase accounts, or copies of licensed files for the purpose of avoiding the purchase of additional licenses.

6. Intellectual Property and Ownership

The Materials and all underlying content, designs, templates, frameworks, diagrams, architecture, written expression, compilation, organization, and other protectable elements are owned by or licensed to Chris Benefield and are protected by applicable intellectual-property laws. This Agreement grants permission to use the Materials; it does not sell, assign, or transfer ownership.

The Benefield Closed-Loop RCM Intelligence Architecture, the Healthcare Data Trust materials, and associated framework names and presentation structures remain the intellectual property of Licensors to the extent protected by applicable law. Licensee retains ownership of Licensee-owned data, content, and original work entered into the Materials.

7. Copies, Storage, and Security

- Licensee may maintain reasonable backup copies and working copies necessary for permitted use.
- Team and Enterprise Licensees may store the Materials in access-controlled internal repositories available only to Authorized Users.
- Licensee is responsible for preventing unauthorized access, copying, and distribution and for removing access when an Authorized User is no longer eligible under the purchased license.

8. Updates and New Versions

A purchase includes only the version, files, updates, and update period expressly included in the offer at the time of purchase. Licensors may revise the Materials, change features, correct errors, or release new editions. Unless expressly promised in the applicable offer, future major versions, add-ons, services, or new products are not included automatically.

9. Educational and Informational Use; No Professional Advice

The Materials are provided for educational, informational, planning, and analytical purposes. They do not constitute legal, medical, accounting, tax, cybersecurity, regulatory, compliance, investment, or other professional advice. Licensee is responsible for validating calculations, data sources, assumptions, policies, legal requirements, contractual terms, clinical implications, security controls, and business decisions before use in production or decision-making.

10. No Warranties

TO THE MAXIMUM EXTENT PERMITTED BY LAW, THE MATERIALS ARE PROVIDED "AS IS" AND "AS AVAILABLE," WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY, NON-INFRINGEMENT, OR THAT THE MATERIALS WILL MEET ANY PARTICULAR BUSINESS, FINANCIAL, TECHNICAL, OR REGULATORY REQUIREMENT. LICENSOR DOES NOT GUARANTEE ANY REVENUE, SAVINGS, COLLECTION IMPROVEMENT, DENIAL REDUCTION, RETURN ON INVESTMENT, OR OTHER RESULT.

11. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW, LICENSOR WILL NOT BE LIABLE FOR INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR LOST PROFITS, LOST REVENUE, LOST DATA, BUSINESS INTERRUPTION, OR SIMILAR LOSSES ARISING FROM OR RELATED TO THE MATERIALS OR THEIR USE. TO THE EXTENT LIABILITY CANNOT BE EXCLUDED, LICENSOR'S AGGREGATE LIABILITY ARISING OUT OF OR RELATING TO THE MATERIALS WILL NOT EXCEED THE AMOUNT ACTUALLY PAID BY LICENSEE FOR THE APPLICABLE PRODUCT DURING THE TWELVE MONTHS BEFORE THE EVENT GIVING RISE TO THE CLAIM.

12. Termination

The license continues unless terminated. Licensor may terminate the license upon material breach of this Agreement. Upon termination, Licensee must stop using the Materials and delete unauthorized or distributable copies. Sections concerning ownership, prohibited uses, disclaimers, limitation of liability, governing law, and other terms that by their nature should survive will survive termination.

13. Governing Law and Venue

This Agreement is governed by the laws of the State of Texas, United States, without regard to conflict-of-law principles, except where applicable law requires otherwise. Any dispute not otherwise resolved by the parties will be brought in a court of competent jurisdiction in Texas, subject to applicable law.

14. Entire Agreement; Changes; Severability

This Agreement, together with the applicable purchase page, invoice, order form, or written enterprise terms, constitutes the agreement governing Licensee's use of the Materials. If a specific written enterprise agreement conflicts with this Agreement, the signed or expressly accepted enterprise agreement controls for that purchase. If any provision is held unenforceable, the remaining provisions remain in effect. A waiver of one breach is not a waiver of another. Licensor may publish updated license terms for future purchases or future versions; changes will not retroactively expand restrictions on a fully paid prior purchase unless required by law or separately accepted by Licensee.

15. Licensing Upgrades and Permission Requests

For additional Authorized Users, enterprise deployment, affiliate use, broader consulting rights, educational licensing, redistribution rights, custom licensing, or any use not expressly permitted here, obtain written permission or an appropriate upgraded license before use.
